8th Annual Taylor County Chili Cook-Off

Rules & Regulations

Saturday, April 3rd, 2010 - 12:00 noon Forest Capital Park, U.S. Highway 19 South

The following rules and regulations will apply to all entries in the 8th Annual Taylor County Chili Cook-Off held on Saturday, April 3rd, 2010 at Forest Capital Park in Perry, Florida:

1. Chili is defined as any kind of tomato sauces, meat, combination of meats, cooked with red or green chili peppers, various spices and other ingredients, including, but not limited to beans and pasta.
2. Chili Cook-Off entries may be pre-cooked and prepared prior to the date of the contest or prepared on-site.
3. Chili Cook-Off entries must be completely prepared and ready to be served by 12:00 noon on Saturday, April 3rd or will be excluded from judging.
4. Chili entries may be kept warm with the use of crock pots or other warming devices during the contest and electrical outlets will be provided.
5. Judging of chili entries will be conducted during a one-hour period immediately following the 12 noon serving deadline. There will be three winning categories – Judges Choice (Most Unique), & Best Over-All as well as the People's Choice (During the People's Choice, spectators will vote for their favorites by placing \$\$ in your collection bowl in front of your chili. The chili-contestant with the most \$\$ collected wins half of all the money collected from ALL chili contestants).
6. Contestants are responsible for supplying their own chili containers, utensils, serving spoons or ladles and any sides (crackers, cheese, sour cream, bread, etc.) they may wish.
7. Each contestant must cook and provide at least a minimum of two gallons of chili at the time the contest begins for judging and serving purposes.
8. Each contestant will be assigned a contestant number by the Chili Cook-Off Chairperson and must provide at least three 8 oz. samples of chili for the judging panel in a pre-marked cup with that contestants number displayed on the outside (Contestant committee will provide cups for this).
9. Judging will be based on the following major considerations: taste (combination of meat, peppers, spices, etc. with no particular ingredient being dominate, but rather a blend of flavors), good flavor, texture, consistency (ratio between sauce and meat, i.e. not dry, watery, grainy, lumpy or greasy), blend of spices, aroma, bite and color.
10. Bowls and spoons will be provided by the Chili Cook-Off Committee and those attending the 8th Annual Florida State Bluegrass Festival will be invited to purchase a bowl for \$5.00. All proceeds will go toward Chili Cook-Off expenses and prizes, with any remainder being retained by the Rotary Club of Perry for their Scholarship Fund.
